As we enter day 47 of social distancing & start the month of May, please remember the new Stay at Home guidelines announced last week are now in effect. Reminders on the new face mask requirement as well as other news from this week are included below in the Information Safety & COVID-19 newsletter for May 1.

**REMINDER Hours of Operation** – as we better understand business needs at our sites under the current norm, don't forget to notify your Parent Marketing Representative and or the Brands Fulfillment Team with any updates and or changes to your sites hours of operation. We will then update this information with the Brand.

**REMINDER Illinois Face Mask Requirement** – today, May 1 starts the new state requirement for all Illinois residents over the age of 2 & who can medically tolerate to do so, to wear a face mask when in public. In the event a face mask is not possible, a face covering will be accepted.

- Requirement The mandate requires when people are working & or visiting essentials businesses such as grocery stores, pharmacies & gas stations, they must wear a face mask. People in the public not wearing a mask maybe subject to a citation and or fine. Note it is not required to wear a face mask while in a car and or home.
- NEW No Mask, No Service Signage in an effort to remind customers of the new state requirement & that stores have the right to turn customers away who fail to wear a mask, we have created the following signage in English & Spanish. This signage contains important reminders we hope will inform customers of this health & safety requirement & diffuse any potential misunderstandings at the counter.

- Using the clean screen feature.


